The first table above provides statistical data for the entire cohort and the subsequent tables relate to each individual fee status group. Applications can vary both in number and quality between cycles therefore we would caution against using these statistics as solid predictors for future applications. We review our selection process annually therefore the way we select is subject to change. As Medicine is a controlled subject the number of places we have available each year per fee status is determined by the Scottish Funding Council in liaison with NHS Scotland annually and is also subject to change. Whilst Republic of Ireland applicants will fall within the Rest of the UK fee rate.

Where applicant numbers fall below five in total the numbers are reflected as such in order to comply with GDPR requirements.

The table above shows the UCAT deciles for the 2021 cycle cohort. Due to the Covid 19 pandemic not all applicants were able to have the same experience when taking the test. Some sat the test at home whilst others were still able to take the test at a test centre. In view of this and early data which suggested some disparity between the two; a decision was taken to separate out the two groups and then divide each group of test takers into deciles which is reflected above.
